

DECLARING SUPPORT FOR HAMAS- WHAT HAPPENS

This update is to reassure signers that the police can't do much if the individual supports Hamas but is not actually donating money to them. (Of course, it will be interesting to see what the courts do to all those thousands charged with wearing a PA T-shirt; all the hearings were on hold whilst the Government appeal was being held.) The man who was arrested, Allen, had the following experience to recount:

Hello,

This story may be of interest to you on the subject of Hamas Proscription:

I was arrested on the 30th MARCH 2024 at the Pro-Palestinian demonstration in Central London over my support for stated HAMAS (see video below).

I was because I was recorded shouting, in response to two (obviously off-duty police holding up signs saying **"HAMAS is a Terrorist Organisation"** – i.e. it was a set-up job), that I fully support HAMAS in exercising their legal right to resist the brutal occupation of Palestine by the racist, apartheid state of Israel. They were standing on a raised concrete bollard with rows of police in front and behind, all part of the UK's state-sponsored protection and support of Israel's crimes and genocide. Several people in the crowd were holding up cameras and asking for clarification. Some moron asked *"Wot eggzactly are you sayin' then?"* to which I replied sharply that *"I fully support HAMAS because they are doing exactly what the French Resistance did in WW!!, they resisted the NAZI occupation of their country and the French Resistance has been celebrated in the UK for 80 years for their acts of heroism"*.

When interviewed by police at a station in Southwark in relation to what I was told was "Supporting a proscribed terrorist organisation", I was shown a video of the whole event and before being asked questions I asked "Is this what this is all about?". When the interviewers confirmed I said "Then I should inform you that I have been trained by a terrorist organisation in all the tools of terrorism; high-powered weapons, sub-machine guns, explosives and so on. That organisation was the Australian Military and they wanted me to go and kill people I didn't know in another country on behalf of a foreign government. Of course, they scoffed but I told them that experience was the root of my vehement opposition to all forms of political violence."

The first part of their questioning probed the nature of my support for HAMAS and ended abruptly when I stated flatly that I have never provided any financial, material or active support for HAMAS, I simply support and admire their courageous resistance to the brutal occupation of their country by the racist, apartheid state of Israel, which is in fact, protected under international law and the fourth Geneva Convention.

Their next line of questioning moved to the suggestion that others might misunderstand my support for Hamas and be led to engage in acts of terrorism. That too collapsed when I pointed out that their own video, just presented, shows me making explicitly clear about my support for Hamas in that I can be heard stating clearly that it is the equivalent of the French Resistance.

After a follow-up round of questioning under caution a week later and four months on bail (which failed to deny me my right to attend pro-Palestine demonstrations) I wrote to the police demanding essentially that they put-up or shut-up I was moved to a status of "under investigation", upon which I wrote a further letter ridiculing this idea that four months of "investigation" on such a fragile foundation reflects badly on their competence. This prompted a reply from the Crown Prosecution Office stating that their legal analysis had concluded that while there was grounds for prosecution it was considered "not in the public interest".

Not to let them get away with this I wrote again to say that:

"I am a 72 year old adult, a Master's degree educated professional, still working to support my family, with no prior arrests or convictions, no drug habits, no history of alcohol abuse or anti-social behaviour and above all, no association with any form of criminal activity whatever. I believe that it is quite contrary to "the public interest"

that a person of my background and character should be cast under the shadow of “sufficient evidence to afford a realistic prospect of conviction” of crimes relating to Section 12 of the UK Anti-Terrorism act. It is absurd!”

The proscriptions of HAMAS by Priti Patel (who took the Israeli junket of being flown to Israel for the red-carpet treatment and a hasbara propaganda indoctrination) and of Palestine Action by Yvette Cooper (a clearly psychotic and mentally retarded individual) are obviously politically motivated actions of governments under the influence of a foreign power and the notion that Israel has suffered the “worst terrorist attack in its history at the hands of Hamas” is a clearly outrageous lie.

I know this; a lot of ill-informed morons don’t.

I don’t mind if you wish to relate this story at your 30th May event but I won’t be paying £8 to come along and hear it.

However, I would be happy to assist in any measure to achieve de-proscriptions if you think any of the likely near-future governments of the UK are likely to be voluntarily persuaded to do so.

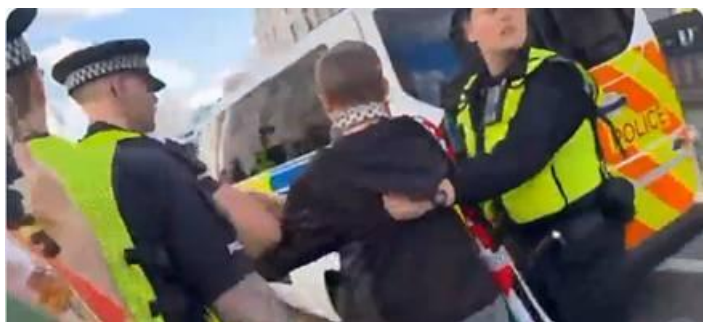
